## Why we collect your data

In accordance with that established in current regulations, CAMPING LA SIESTA, SL only collects those data strictly required for us to offer the services derived from our activities and other features, administrative tasks and activities as provided for by the law.

- We recommend that all users use personal pseudonyms or nicknames for the purposes of the Internet, which will allow them to possess an authentic "digital identity" that does not compromise the security of their personal and professional lives.
- We recommended that users take special care when publishing audiovisual and graphic content in their profiles, as these actions may put the privacy of people in their personal and/or professional environments at risk.



- We recommend that users check and read (both before user registration, and subsequently) the general conditions of use and the privacy policy that the platform places at their disposal on their websites.
- We recommend adequately configuring user profile privacy levels in the social network, so that the profile is not completely public, but only accessible to those persons classified as "friends", who will have access to the information published in the profile, or to those "direct contacts" previously chosen by the user.
- We recommend that you accept as contacts only those persons known to you personally or with whom you have a prior relationship, and do not automatically accept all contact requests you receive, while investigating whenever possible and necessary the identity of the person requesting your contact through the social network.
- We do not recommend publishing physical (geographical) contact information in user profiles that allows third parties to know where users live, work, study or the places that they usually frequent during their leisure time.
- With respect to the users of microblogging tools we recommend taking special care regarding the publication of information on where they are at all times.
- We recommend only using and publishing content covered by intellectual property rights, if not users may be liable for committing a civil offence under Spanish legislation.
- We recommend that users use different user names and passwords to enter the different social networks they belong to.
- We advise using passwords with a minimum length of 8 characters, numbers and with capital and lowercase letters.
- We recommend that all users install and suitably update antivirus software on their computers.
- Minors should not reveal excessive personal data. Never provide this data to strangers.
- All the information concerning the website must be read. It provides information on the website owners and why data is requested.



- If any user is under fourteen years of age, the consent of the parents or guardians is also needed. In such cases, whenever data is requested by a social network, the parents or guardians must be asked for their approval to any subscription.
- Usernames and passwords should not be communicated to third parties, nor shared among friends or classmates. This information is private and should not be revealed to any other persons or strangers.

- Activate parental control and platform control tools and use the email address of a parent or guardian as a secondary contact email address.
- Ensure that age verification controls are in place.
- Ensure that the content blocker has been correctly installed.
- Raise awareness and inform minors about security-related aspects.
- Explain to children that they must never meet people they have met in the online world and that if they do, they must always meet them in the company of their parents or guardians.
- Ensure that minors understand the risks and implications of hosting content such as videos and photographs and are aware of the risks involved in using webcams on social networks.
- Control all minors' user profiles.
- Ensure that minors only access those pages recommended for their age.
- Ensure that minors do not use their full names.
